## CONSENT CALENDAR:

The Consent Calendar was presented for approval of the following minutes:

Ms. Braxton motioned to approve the items on the Consent Calendar as presented. Motion seconded and carried unanimously.

<u>Action Item A-1</u> was presented for approval of the proposed CBH Board Attendance Policy. This policy is designed to help assure that individuals appointed to serve on the CBH Board of Directors remain accountable to local jurisdictions that rely on CBH to provide the best services possible with the resources provided. Discussion.

Dr. Gill motioned that the proposed CBH Board Attendance Policy be referred back to the Executive Committee for further discussion. The motion was seconded and passed unanimously.

**DATE for 2020 BOARD PLANNING DAY:** The CBH Board Planning Day has historically been scheduled the last Friday in July. The decision was unanimous to schedule the CBH Board Planning Day on July 17, 2020.

# EXECUTIVE DIRECTOR'S REPORT:

The Executive Directors Report was provided in writing and distributed to Board Members.

Mr. Keith German was recognized for attaining his 35th year anniversary of employment with Colonial Behavioral Health (CBH). The CBH Board of Directors extended appreciation to Mr. German for his ongoing commitment to the agency, clients, and localities served.
